

Understanding's Legal Corner

DID YOU KNOW?



After becoming the first African American to captain a vessel in the U.S. Navy, Smalls entered local politics and helped establish schools and social services for freedpeople in his hometown of Beaufort, South Carolina.

Robert Smalls and 259 other African Americans in 1868 helped draft the S.C. Constitution, which was the only S.C. Constitution ever voted on by the people of S.C. Most whites refused to vote for it, but it was ratified by S.C. voters. In 1868 the population of S.C. was roughly 300,000 whites and 400,000 blacks. This Constitution was replaced by the present S.C. Constitution of 1895, which was not submitted to the people of S.C. for a popular vote. The S.C. Constitution of 1895 is the work of Bill Tillman, one of S.C.'s most racist Governors. By 1892 Tillman finally had enough support in the legislature to authorize a referendum on whether to call a constitutional convention. The convention began on September 1,1895 with an opening demand by Barnwell County Delegate Robert Aldrich that the S.C." Constitution on 1868 had to be repealed because it was drafted in part by negroes and was a stain on the reputation of S.C". The S.C. Constitution of 1895 was never put to the people of S.C. for ratification by popular vote, under the justification that since the people voted them into office, they spoke for the people and ratified it on their behalf.
